ERF ANNUAL CONFERENCE

The Economic Research Forum's (ERF) Annual Conference, a tradition maintained since 1995, has become the premier regional event for economists of the Middle East; where new ideas are created and disseminated, where the community of researchers meet, and where excellence is celebrated. This year's conference is very special as it marks the anniversary of the ERF, which was established in 1993 to build a strong research capacity in the region. It was one of the first institutions to connect economic researchers from across the region.

This year's conference is held under the theme of *Knowledge, Research Networks, and Development Policy*. Hosted by the Arab Fund for Economic and Social Development, it will be held throughout 10-12 March 2019 in Kuwait City, Kuwait. This is a timely topic in light of the significant political, social, and economic transformation currently witnessed in the region, and it is also highly relevant to ERF's celebration of its achievements, aspirations, community, and partners. The plenary sessions will feature world-renowned economists and thought leaders to provide valuable, thought-provoking ideas and viewpoints to take forward the region's agenda towards economic growth and sustainable development.

The design of this year's conference will be different from previous years. There will be four main plenary sessions, and two special panels, which will feature prominent economists, social scientists, and policymakers. This year, a number of special events will be held in celebration of the ERF's anniversary. The parallel sessions will feature a larger number of diverse papers across cross-cutting critical themes selected on the basis of a rigorous refereeing process in response to an open call for papers. The closing plenary session will celebrate the winners of what has become a regional certificate of excellence: The Best Paper Award. The ceremonial gala dinner will be an opportunity to express the gratitude and acknowledgement of the ERF's founding members and management, and to the ERF prestigious community of researchers who have enriched the ERF with their valuable contributions.

Conference Theme

Countries in the MENA region face a myriad of lingering and emerging development challenges, ranging from achieving sustained job-creating growth to meet the youth bulge and dealing with climate change and environmental degradation, to building peace and reconstructing societies and economies coming out of conflicts. The answer has been and will continue to be *strong institutions and good governance*. However, in the emerging increasingly *digitalized* global economy, MENA, like other developing regions, should deploy whatever institutional capacity it has to promote meaningful knowledge- and innovation-based development policy. As an economic development model, *Knowledge Economy* is based on the creation, transfer, and dissemination of knowledge and innovation. It hinges on four pillars: *economic and institutional framework, educated and skilled population, innovation systems, and dynamic information infrastructure*. These four pillars are necessary to create knowledge that needs to be transformed into products valued by the MENA markets to promote growth, create jobs, and increase welfare. Although some countries in the region have adopted concrete plans towards building knowledge economies and have started to invest in these four pillars, more work needs to be done, especially for those who have yet to take the first preliminary steps.



Networks, such as social networks, firm networks, and research networks, are major players in the *Knowledge Economy*, where they expand information and technologies and catalyze ideas and resources. For instance, social networks are widely used in the current economic literature given their importance in understanding the behavior of individuals and their decisions. In turn, this facilitates the implementation of policies that would effectively impact individual behaviors. Firms and research networks allow for the production and dissemination of knowledge as well as the creation of new jobs, which is crucial for the MENA region in light of its high level of structural unemployment, especially among youth.

Therefore, governments and other stakeholders in MENA countries should view the *research network* as a centerpiece of the eco-system of the envisaged knowledge economy that can achieve sustainable job-creating growth in the emerging technology- and knowledge-intensive global economy.

Plenaries, Panels, and Special Sessions

Three plenaries are planned to address the following issues: first, *Knowledge, Economic Research Networks and Development Policy*; second, *The Role of Knowledge in the Process of Innovation in the New Global Economy*, and third, *Job-creating Growth in the Emerging Global Economy*. Another special plenary highly relevant to the ERF's anniversary asks the question of which schools of thought have dominated economic research and policymaking in MENA and how they evolved over time. In addition, the first panel documents the emerging role of the ERF in partnership with statistics offices in the region as a premier repository of labor, households, and other micro datasets from the region. The second panel addresses the role of the new ERF research agenda in tackling new challenges faced by the region. Finally, there will be a special session on the Faces and Voices from the ERF Community reflecting on their past experiences with the ERF and their aspirations for the future.

Plenary Session 1: Knowledge, Economic Networks, and Development Policy

The use and application of knowledge along with the expansion of information and communication technologies, known as the Knowledge Revolution, are a major source of economic development. However, MENA countries lag behind other countries in this regard, given the low investment in education, information infrastructure, and research and development. Thus, economic networks connecting firms with researchers, universities, and other stakeholders as policymakers and international organizations allow for the creation, transfer, and dissemination of knowledge and innovation. This knowledge may lead to the emergence of new industries or the reform of existing ones, which will therefore result in creating jobs, increasing growth, and achieving sustainable development.

This panel aims to tackle the process of moving forward on the path towards a knowledge economy by answering the following questions:

- What are the main barriers facing the MENA region?
- What are the main lessons to learn from the International community?

- What is the role of existing research networks, such as the ERF, in catalyzing knowledge and achieving sustainable development?
- What is the likely future direction of development research in the new era of digitalization, big data, and GVCs, and how should development research networks, such as the ERF, shape their future research agenda?

Plenary Session 2: The Role of Knowledge in the Process of Innovation in the New Global Economy

In a new global economy witnessing a knowledge revolution, investment in intangible assets has become the main characteristic of the *Knowledge Economy*. This intangible economy is driven by proprietary knowledge, ideas, and innovation. Although characterized by high upfront costs as well as high risks, these intangible investments pave the way for low marginal costs and large potential returns and rewards to strategic behavior.

Therefore, this panel will discuss the following questions:

- What are the main conditions needed for intangible investment?
- What are the main channels needed to produce knowledge and transform it into innovation in the MENA region?
- What is the institutional framework needed to incentivize the creation of patents and proprietary knowledge?
- How can we achieve a balance between protecting intellectual properties and protecting consumers against the power of innovative firms? What role should governments play on the national, regional, and global scales?

Plenary Session 3: Job-Creating Growth in the Emerging Global Economy

A knowledge- and innovation-based economy requires young educated and skilled population able to utilize current knowledge to create new ideas that can be transformed into new products valued by the market. Innovation Networks such as “cluster” or “milieu innovateur” include innovative firms, universities, and other institutions. Created locally or globally, these networks are prime sources of knowledge creation and innovation. New ideas are therefore transferred and diffused between the different members of the network; consequently, creating new jobs to absorb new entrants to the labor market.

Therefore, this panel will attempt to answer the following questions:

- How might the emerging digitized global economy and GVCs, among others, affect the development strategies for MENA and other developing countries, including regarding:
 - o The relative effectiveness of manufacturing and services as enablers of job-creating growth
 - o The role of knowledge and innovation in shaping public policy and development strategies in general

- How might the collaboration between innovative firms and universities solve the existing mismatch between the outputs of the educational system and the needs of the labor market?
- What are the main challenges faced by the MENA region to invest in skilled and educated human capital? And what is the role of early childhood education in developing the skillsets needed for new jobs?
- How will governments react to the unemployment created by the disappearance of jobs due to the emergence of new technology and knowledge?

Special Plenary: Schools of Thought and Economic Research and Policymaking in MENA

This special plenary deliberates the schools of thought that dominated the economic sphere in MENA. The discussions, which are based on a region-wide survey of economists, aim to apprehend how economic policies are and have been designed in MENA. Given the recent political and economic changes in the region, it is important to understand how the schools of thought play a role in shaping public policies as well as overall development strategies.

Panel 1: From Data to Policy – Rewarding Partnership with Statistics Centers in the Region

This special plenary will convene the heads of National Statistical Offices (NSOs) from the region, as well as researchers and policymakers, to celebrate the achievements of the ERF Open Access Micro Data Initiative (OAMDI), and to showcase the ERF data collection and harmonization efforts made possible through the strategic cooperation with NSOs. The session will also highlight the value of sharing micro data and emphasize the research-to-policy link.

Panel 2: ERF in the Emerging New Normal and the Changing Nature of Works

The ERF is a research network that generates and disseminates knowledge addressing the main challenges faced by the MENA region. These challenges include large scale violence and civil wars, inequality, employment, climate change, environmental damage, and subsidies and social justice.

However, in the emerging global context of technological progress and innovation changing the nature of work and the dramatic decline in oil prices known as the *New Normal*, these challenges will remain, and new challenges will appear. Although innovation is known to transform living standards, it may be the reason behind widespread unemployment as John Maynard Keynes warned in 1930. However recent research, for example, the new World Development Report 2019 *The Changing Nature of Work* showed that technology will provide “opportunities to create new jobs, increase productivity, and deliver effective public services. Through innovation, technology generates new sectors and new tasks.”

Against this backdrop, this panel will reflect on the quarter century of ERF research and policy outreach, including the first two years of the current ERF Strategy 2017/2021, and explore the future direction of the ERF, accounting for ideas from a wide and diverse group of ERF researchers; policy makers from the region; and partners from the development and knowledge community.

Abdlatif Al-Hamad is director general and chairperson of the board of directors of the Arab Fund for Economic and Social Development; chairperson of the Board of Trustees of the ERF; trustee at the Arab Planning Institute; member of the International Finance Corporation Banking Advisory Board Group (World Bank); board member of the Kuwait Investment Authority; chairperson of the Development Committee Task Force on Multilateral Development Banks; and board member of BlackRock. Since the early 1960s, he has been highly active in promoting economic and social development, particularly in the Arab world. He served as chairperson of the United Bank of Kuwait (1966-1981) and executive director of the Arab Fund for Economic and Social Development (1972-1981). In addition, he was Kuwait's minister of finance and minister of planning (1981-1983). Al-Hamad has also served on numerous commissions and boards, including the United Nations Committee for Development Planning (1982-1991) and the Commission on Global Governance (1992).



Touhami Abdelkhalek is a professor of higher education at the National Institute of Statistics and Applied Economics (INSEA) in Rabat, Morocco. He has worked as a consultant for numerous national and international organizations in Morocco as well as several Arab and francophone African countries (ONDH, World Bank, PNUD, UNICEF). Currently, his expertise spans the quantitative, statistical (surveys), and econometrics aspects of development issues (poverty, inequality, public policy impact evaluation and economic modeling). In 2005, he was the chapter author of Poverty in Morocco, as part of the 50th anniversary report on 50 years of human development in Morocco (RDH50). Furthermore, he was decorated as a Knight of the Throne medal (Wissam Al Arch) by His Majesty the King of Morocco in July 2017.



Adel M. Abdellatif is Senior Strategic Advisor, at the Regional Bureau for Arab States, of the United Nations Development Programme. In this post he oversees the UNDP flagship Arab Human Development Report (AHDR). Recently he coordinated and supervised the AHDR 2016 on "Youth and the Prospects for Human Development in a Changing Reality". He advises on UNDP policies in the Arab Region and leads the strategy of implementing Agenda 2030 in Arab countries. He came to UNDP following a two-decade career at the Ministry of Foreign Affairs of Egypt. He holds a doctoral degree in Political Economy from the Graduate Institute of International Relations, Geneva, Switzerland.



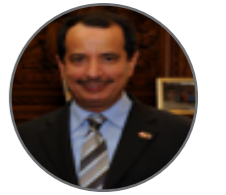

He received his D. Phil. in development economics from the New School for Social Research in New York, M.Phil. in development planning and environment from the University of Dundee in Scotland, and his BA in economics from the American University in Cairo.



Almukhtar Saif Al-Abri is an associate professor in the department of economics and finance, Sultan Qaboos University, and has been a faculty member of the department since 1997. His teaching interests are in the areas of microeconomics, macroeconomics, applied econometrics, and international money and finance. His research interests focus on exchange rate economics, international financial integration, and the macroeconomics of oil exporters and importers. He served as editor and supervisor of the economics section in the Omani Encyclopaedia, inaugurated in 2014. He has published in a number of internationally refereed journals including: Economics Letters, Economic Modelling, International Review of Economics and Finance, International Review of Applied Economics, and OPEC Energy Review. Al-Abri was awarded the Outstanding Academic Award by Sultan Qaboos University in 2011.



Shireen AlAzzawi is a lecturer in the economics department of the Leavey School of Business, Santa Clara University, USA, and an ERF research fellow. Currently, Al Ebraheem is an economic advisor at Amiri Diwan in the capacity of a minister. He has a PhD in economics from Claremont Graduate University, and has authored a number of publications, reports, research papers, and books.



Fatima Al-Shamsi is deputy vice chancellor for administrative affairs at Sorbonne University, Abu Dhabi, and is the former secretary general of United Arab Emirates University. She holds a PhD in economics from the University of Exeter, United Kingdom, and a Master of Economics from the University of Baltimore, USA. She held several academic and administrative positions and served as a consultant to the UAE National Human Resource Development and Employment Authority. Al-Shamsi's research interests deal with economic development issues and women studies. She has many research publications in refereed academic journals and presented research papers in different scientific conferences. She is currently the vice chair of the board of trustees of the Arab Gulf States Institute, Washington D.C., and a member of the ERF board of trustees since 2014.



Hassan Aly is an emeritus professor at Ohio State University since 2015. He has been climbing the ranks of faculty at the university's economics department since 1989 to reach the full professor status. Aly also serves as a consultant (technical advisor) to the IMF (2012-present). His previous positions include his role as the founding dean of the School of Public Administration and Development Economics in Qatar (2014-2016) and lead economist at the African Development Bank (2009-2012). He is a former professor of Sociology and Urban Planning at the Massachusetts Institute of Technology's. An award-winning author, commentator and educator, he has led groundbreaking research in economic opportunity, democracy and governance, segregation, and racial and ethnic diversity in cities and metropolitan regions. From January 2009 to August 2011, Briggs served as Associate Director of the Office of Management and Budget in the White House. Earlier in his career, Briggs served as a Community Planner in the South Bronx, a Policy Adviser and R&D Director at the U.S. Department of Housing and Urban Development, and a Faculty Member in Public Policy at Harvard University's Kennedy School of Government. Briggs holds an Engineering degree from Stanford University, an MPA from Harvard and a Ph.D. in Sociology and Education from Columbia University.



Mouna Cherkaoui is a professor of economics at Mohamed V University Faculty of Law, Economics and Social Sciences in Rabat Agdal since 1989. She previously served as an advisor to the minister of higher education and scientific research. Cherkaoui was a member of the Advisory Committee on Economic Research and Policy Analysis on gender (GERPA) of the World Bank. She was invited as a teacher and researcher to many universities and conducted research and consultations for various national and international organizations such as UNCTAD, UNDP and the World Bank. Her research focuses on topics related to macroeconomics, financial markets, economic development and growth. She also coordinated a number of research projects related to international trade, pro-poor growth and migration. She received her PhD in economics from Arizona State University. Cherkaoui is an ERF research fellow and a member of the Arab Development Portal Strategic Advisory.



Mine Cinar has taught in Texas A&M, Oklahoma State, and Bogazici Universities, and was a research fellow in the University of Wisconsin, the Poverty Institute, and Northwestern University, MEDS. She is director of the Center for International Business at Loyola University, Chicago. She has received grants from Fulbright-Hays, the Ford Foundation, the Population Council, and the SSRC. Cinar has published works on different aspects of economic development, finance, and gender. She is the former president of the Middle East Economics Association and is the editor of the online proceedings journal. Cinar holds a master's degree from Vanderbilt University and received her PhD from Texas A&M University.



Paul Collier is a professor of economics and public policy at the Blavatnik School of Government, University of Oxford. His research covers fragile states, restoring growth in African economies, the implications of group psychology for development, migration and refugees, urbanization in poor countries, and the crisis in modern capitalism, which is the subject of his most recent book, *The Future of Capitalism*. He received a knighthood in 2014 for his services in promoting research and policy change in Africa, and has been listed as one of the 100 most influential public thinkers in five of the past ten years.



Ishac Diwan is the chair d'excellence monde arabe at Paris Sciences et Lettres, and visiting professor at SIPA, Columbia University. His research focuses on topics related to the political economy of the Middle East, development and growth in Africa, financial flows, and domestic and global trade issues. He received his PhD in economics from the University of California, Berkeley. He is an ERF research fellow and a member of the ERF board of trustees.



Ibrahim Elbadawi is managing director of the ERF. Earlier, he served as director of research at the Dubai Economic Council, which he joined in March 2009. Before that, he was lead economist at the Development Research Group of the World Bank, which he joined in 1989. He has published widely on macroeconomic and development policy, democratic transitions and the economics of civil wars and post-conflict transitions. He was the thematic leader of the Natural Resource Management and Economic Diversification theme at the ERF for five years and is a member of the advisory board of the Arab Planning Institute. He holds a PhD in economics and statistics from North Carolina State and Northwestern Universities.



Noha El-Mikawy is a representative of the Ford Foundation's MENA office in Cairo. Her work concentrates on issues of inclusion in social, economic, and cultural rights; independent arts and culture; and the role of local philanthropy in the region. Between 2005-2012, El-Mikawy served as team leader for governance at the UNDP regional center for the Arab states and as policy adviser at the UNDP's Oslo Governance Center in Norway. Between 1999-2005, she led comparative research on the political economy of MENA at the Centre for Development Research of the University of Bonn, Germany. Before that, she lectured on politics of the Middle East at the American University in Cairo, Free University of Berlin, and Erlangen-Nuremberg University in Germany. El-Mikawy holds a PhD and MA from the University of California, Los Angeles, and has three books and multiple articles on the political economy of MENA.

Yasmine Fahim is director of research and programs at the ERF. Her research areas of interest include labor markets, education, and women empowerment. She is a graduate of the faculty of economics and political science of Cairo University.



Shahrokh Fardoust is a research professor at the Global Research Institute at the College of William and Mary. From 2008 to 2011, he was director of strategy and operations, Development Economics, the World Bank. His previous positions at the World Bank included senior adviser to the director-general of the Independent Evaluation Group, and senior economic adviser to the senior vice president and chief economist. He is co-editor of and contributor to *Post Crisis Growth and Development: A Development Agenda for the G20* (World Bank, 2011); and *Towards a Better Global Economy: Policy Implications for Global Citizens Worldwide in the 21st Century* (Oxford University Press), 2016. He is a member of the SovereignNet Advisory Council at Tufts University; member of the Expert Advisers group for the European Investment Bank-Global Development Network project; non-resident scholar at the Middle East Institute, Washington, DC; and member of Millennium Challenge Corporation's, Economic Advisory Council. Fardoust obtained his PhD in economics from the University of Pennsylvania.



Hafez Ghanem is vice president of the World Bank for Africa since July 2018. A development expert with over 30 years of experience, Ghanem leads an active regional portfolio consisting of over 600 projects totaling more than \$71 billion. Prior to his appointment, Ghanem served as vice president of the World Bank for the MENA region (2015-2018), overseeing the World Bank's engagement with 20 countries. Leading up to this, he was a senior fellow at the Brookings Institution in the Global Economy and Development Program. He also served as the assistant director-general at the Food and Agriculture Organization of the United Nations (FAO) (2007 – 2012). He has many publications in professional journals and was a member of the core team that produced the World Bank's 1995 World Development Report. He holds a bachelor's and master's degree in economics from the American University in Cairo and a PhD in economics from the University of California, Davis.



Ahmed Ghoneim is currently a professor in the faculty of economics and political science at Cairo University. He is a research fellow at the ERF for Arab Countries, Iran, and Turkey, and the Center for Social and Economic Research in Poland. He is a consultant to several international and national organizations including the World Bank, WTO, UNCTAD, UNDP, and the World Intellectual Property Organization (WIPO). He holds a PhD in economics and has published widely in trade policy, trade in services, regional trade integration, and political economy, among others. Heba Handoussa is founder of the Egypt Network for Integrated Development (ENID) since 2012. She was the lead author of the Egypt Human Development Report (EHDR) 2010, which was the best report across over 50 countries, as well as the director and lead author of three previous EHDRs. She was founder and director of the ERF for Arab Countries, Iran, and Turkey. Handoussa taught at the American University in Cairo and has consistently served as an advisor to the Egyptian government. 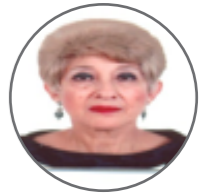

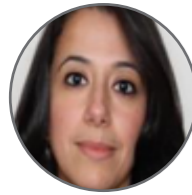
