**Profile:**

**A- Research and Academic International recognition**

I have been at Newcastle University Business School since June 2017. I gained my PhD in Accounting from the University of York, and my research interests cover the role of accountability, disclosure and financial reporting, **corporate social responsibility, risk, business history and accounting history**. My research examines managerial disclosure and the performance of oil companies during nationalisation and independence. My published work has focused on the governance process and systems that underpin **corporate actions and accountability on sustainability issues**, as well as on the role that sustainability information plays in financial markets during crisis. I have more than **22 publications** in leading academic journals such as, among others, **Business History journal (4), British accounting Review Journal (3), Enterprise and Society journal (3), Accounting History journal (3) and Critical Perspectives in accounting journal (3)**. I have also published edited books, book reviews, policy reports, technical articles, and industry-based articles. This recognition reflects not only **the high quality and relevance of my research** but also its appeal to a broad scholarly audience. My research methodology, which integrates a scale of **interdisciplinary approaches**, has enabled a diverse contribution to a range of interdisciplinary journals, **attesting to the sustainability and excellence of my scholarly output**.

I was awarded three research grants. The first is 120,000 AED (£25,000) in collaboration with Liwa College Abu Dhabi to study barriers, perspectives and policy gaps in digital maternal healthcare in the UAE using mixed methods and an intervention componPHent. The second is 50,000 AED (£15,000) through the ADU-LC Global Collaborative Research Grant Program to compare public awareness and access to digital mental health services in the UAE and the UK. The third is a £15,000 grant from Kuwait

University where I serve as Principal Investigator on a project on oil revenue management and nation building in Kuwait, 1951 to 1967. These projects expand my research profile in accounting and applied policy research. They also develop cross-GCC collaborations with international partners from GEP member institutions and link academic work to industry needs.

## **B- Engagement and Knowledge Exchange Achievements**

**Highly engaged with both the academic community and practitioners.** I am acting as a mentor in the BASNET Research Mentorship Programme, I have had a profound impact on advancing the research capacity and representation of Black and Minority Ethnic (BME) researchers and organisations in the anti-slavery and anti-trafficking sector. By providing tailored guidance and mentorship, I have empowered early-career researchers to develop and execute high-quality, impactful research projects that address pressing issues such as modern slavery, human trafficking, and racial inequality.

Through my mentorship, mentees have gained critical skills in research design, methodologies, data collection, analysis, and presentation. This enhanced capacity has not only increased their confidence and competence but also enabled them to produce research that directly influences policy and practice in the sector. By fostering collaboration and adopting a co-production approach, I have ensured that mentees' work authentically reflects the lived experiences and needs of BME communities, making their research both relevant and actionable.

The programme has further benefited from my leadership in capacity-building workshops, where I have shared insights and practical knowledge, equipping mentees with the tools to undertake interdisciplinary and applied research. This has strengthened their ability to address systemic inequalities and advocate for change. My contributions to documenting and reporting the mentorship process have also added value by capturing challenges, successes, and lessons learned, which have informed recommendations for improving future mentorship initiatives.

The impact of my mentorship extends beyond individual mentees. By supporting BASNET's advocacy goals, I have encouraged research that amplifies the voices of BME-led organisations and individuals with lived experience. The dissemination of this research to policymakers and stakeholders has helped shape a more inclusive, diverse, and equitable anti-slavery and anti-trafficking sector.

Overall, my mentorship has not only empowered emerging researchers but also contributed to systemic change by strengthening the capacity of BME-led organisations to influence policy, practice, and public awareness. This work has demonstrated the far-reaching impact of effective mentorship in driving meaningful progress and promoting equity in research and advocacy.

It is worth highlighting that I took part in the BME Modern Slavery Knowledge Mobilisation Conference, which was a strong success. My commitment, collaboration and sustained effort over recent months helped shape the event. The research presented and insights shared reflected the programme's goal of producing community-led work that challenges assumptions and drives real change.
